City Hall, 403 3rd Street Call to Order: Mayor Nathan Weitl called the meeting to order at 5:30 p.m. Roll Call: Council present: Gregor Ernst, Jeff Miesner, Jason Schable, Reynold McLead and Jared Bogue. Others in attendance: Nathan & Jessi Oldham (electronically), County Engineer Jeff Williams, Northland Securities Chip Schultz (electronically), Dale & Shelley Schiernbeck, Attorney's Reininger & Goldsmith and City Clerk Sweeden. Approval of Agenda: Motion by McLead, second by Bogue to approve. Motion carried 5-0. Public Hearing - Oldham's Great Dane IGCC 6.05.170 (1): Weitl announced the opening of a public hearing to determine whether Nathan and Jessi Oldham's Great Dane should be deemed vicious per City Code Chapter 6.05.170 (1). The City Code defines a vicious animal as follows: "Vicious animal" means any animal, except for a dangerous animal per se, as listed in this section, while running at large that has attacked or bitten any person without provocation, or any animal that has exhibited vicious propensities in present or past conduct (1) by biting a person or persons on two separate occasions within a 12-month period; or (2) did bite once causing injuries above the shoulders of the person; or (3) could not be controlled or restrained by the owner at the time of the bite to prevent the occurrence; or (4) has attacked or bitten any domestic animal or fowl on two separate occasions within a 12-month period, or (5) which has been found to possess such propensity by the city council, after hearing. Oldham's were served notice of the hearing and attended electronically. Weitl asked for comments or questions. Oldham's explained the circumstances of the most recent attack on May 25, 2025. Oldham's were on vacation and had a teenager caring for the dogs when they escaped. Oldham's were notified by the Ida County Sheriff's Office that their Great Dane attacked Schiernbeck's dog, on Schiernbeck's property, causing injury and requiring an emergency vet visit. Oldham's admitted this is not the first instance

of the Great Dane attacking an-

other animal. On March 11, 2025,

the Great Dane attacked Dan &

Renae Remer's dog, unprovoked

and on Remer's property, causing

injury and requiring an emergency vet visit. Oldham's stated their Great Dane is 4 years old, a good dog, has never shown aggression towards humans and that they have applied for a building permit to construct a fence to rectify the dogs running at large in the future Council closed the hearing at 5:48 pm. Council Decision on Oldham's Great Dane IGCC 6.05.170 (2): Motion by Bogue, second by McLead to deem the dog vicious and cause for it's removal from city limits or dispose of it in a humane manner per 6.05.170 (2) of the City Code. Ayes: Bogue, McLead. Navs: Schable, Miesner, Ernst, Motion defeated 2-3. Motion by Ernst, second by Miesner to place the Great Dane on a probation period for 6 months, requiring the owners come before City Council for a hearing on Dec. 15, 2025 at which time the Oldham's will have erected a fence (within 2 weeks of today) and the Great Dane will have completed obedience training and will not have any additional instances of running at-large or attacks. Ayes: McLead, Ernst, Schable, Miesner. Nay Bogue. Motion carried 4-1 Reininger will draft the agreement In the event Oldham's decline to sign the agreement, the topic shall be added on the next agenda. Jeff Williams, Ida County Engineer -Cost Share Request for Paving Kevstone Ave: Williams asked for council's interest in partnering with the County and School to pave the north/south section of gravel, east of the high school football field, to the first intersection. Estimated total cost is \$249.600 which would ideally be shared equally between the 3 parties. After discussion, council's stance was this would not be feasible due to other street maintenance needs the city has throughout town and lack of funding for street projects. Chip Schultz, Northland Securities - Wastewater Project Funding Scenarios: At this time an official offer from USDA has not been received, however, feedback indicates the city could expect an offer of \$1 million in loan forgiveness and an interest rate of 3.375% for loan proceeds over the initial agreement. Council will review the circumstances and official offer at the July 7, 2025 meeting at which time a determination of bid acceptance or rejection will also be made. Jeff Gilbert 1000 5th Street - Requesting Permission to Install Culvert & Fill Ditch with Dirt to Level: Gilbert submitted a building permit application to connect to and extend the existing culvert on the east side of his property along Rohwer Street. Additionally, Gilbert requested to fill the ditch with dirt in order to level the property for caretaking purposes. Motion by Ernst, second by Miesner to approve the request upon Gilbert agreeing to sign a hold harmless agreement and easement. Motion carried 5-0.
