## **PROCEEDINGS: IDA COUNTY PUBLIC SAFETY • AUG. 20 MINUTES**

#### MINUTES

IDA COUNTY PUBLIC SAFETY AND COMMUNICATIONS

COMMISSION AUG. 20, 2024 • 7 p.m. GALVA CITY HALL

Mayor Gary Chase called the August 2024 meeting of the Ida County Public Safety and Communications Commission to order at 7:07 p.m.

The Following members were present: Mayor Gary Chase; May-or Gary Wanberg; Mayor Charlie Pierce and Mayor Kathy Breyfogle. Supervisors Devlun Whiteing and Creston Schubert. Also, present Sergeant Corey Trucke from the Ida County Sheriff's Office.

Mayor Gary Wanberg made a motion to approve the agenda. Second by Supervisor Creston Schubert. Motion carried.

Mayor Kathy Breyfogle made a motion to approve the minutes from the previous meeting (June 18, 2024). Second by Supervisor Devlun Whiteing. Motion carried. Sergeant Corey Trucke was in attendance and gave the Sheriff's report on behalf of Sheriff Wade Harriman.

He told the commission that the Sheriff's Office had logged a total of 674-hours on patrol in July and responded to 815-calls for service. In addition, the Sheriff's Office made a total of 21-arrests and booked in 24-inmates to the county jail during July. Of those, 21 were booked on misdemeanors and 3 on felony charges. Deputies issued a total of 239-cita-

tions during the month and served a total of 57-civil processes.

During the jail portion of the meet-ing, Sergeant Trucke advised the commission that the Iowa Department of Corrections had conducted their annual jail inspection on July 13, 2024 and the only comment item was to replace a few mattresses that were cracked.

During the personnel time of the meeting Sergeant Trucke told the commission that Deputy Brandon Bollmeyer graduated from the Iowa Law Enforcement Academy on Aug

16, 2024 and is now back on patrol duties.

He also stated that Chief Deputy Fred Anderson would begin his 4th vear in the role of school resource officer for the counties schools.

During unfinished business, Sergeant Trucke told the commission that Sheriff Harriman would be meeting in the near future to dis-cuss a change to the funding of the Unified Law Enforcement System. The goal is to equalize the percentage that each entity pays when fac-toring in their \$1.50 levy.

During new business, Sergeant Trucke said the Sheriff's Office will once again be in the schools during Red Ribbon Week in October and that the Sheriff's Office will instruct the DARE program to all 5th grade students in the county.

Next meeting is scheduled for October 15, 2024 at 7 p.m. in Holstein, lowa.
